

MONTHLY ATTENDANCE BULLETIN - SEPTEMBER 2025 TO JANUARY 2026

The purpose of this bulletin is to keep schools informed of overall attendance data on a monthly basis across all settings and to highlight areas where improvement is required.

The Department receives monthly attendance from C2K in or around the 18th of each month, reflecting attendance data from the start of the academic year until the end of the previous month.

These figures are then summarised and shared with senior management within both the EA and DE.

- an 1.1% point decrease in regular attendance;
- a 0.2% point increase in at risk attendance;
- a 0.7%-point increase in chronic attendance; and
- a 1.4%-point increase in severe chronic attendance
