# 11. TEACHERS' SALARIES (REORGANISATION ALLOWANCES) (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 1993

- 1. The Department wishes to draw attention to the above regulations which came into operation on 12 November 1993.
- 2. The Teachers' Salaries (Amendment No. 2) Regulations (Northern Ireland) 1993 -S.R. No. 447 amends S.R. 1993 No. 318 as amended by S.R. 1993 No. 403 and
  - i. removes the need for a qualifying period of service in Northern Ireland as a condition for receiving salary while absent due to illness; and
  - ii. provides for the relevant body of a special school to determine the number of teachers to be paid as vice-principals.
- 3. The Teachers' Salaries (Reorganisation Allowances) (Amendment) Regulations (Northern Ireland) 1993 S.R. No. 446 amends S.R. 1987 No. 385 and -

provides for the new pay structure which was introduced by the Teachers' Salaries (Amendment) Regulations (Northern Ireland) 1993 - S.R. 1993 No. 403 to be taken into account when calculating the amount of reorganisation allowance to be paid.
