DEVELOPMENT PROPOSAL No. 232 – ESTABLISHMENT OF A SINGLE NURSERY UNIT AT BALLYMAGEE PRIMARY SCHOOL

Issue:	The proposal to establish a single nursery unit at Ballymagee PS, Bangor with effect from 31 August 2013, or as soon as possible thereafter.
Timescale:	Urgent - an early decision would clarify the position for interested parents.
Financial / Resource Implications	A high-level funding estimate for an additional 26 part- time place nursery unit is approximately £49,000 per annum or £28,000 in-year.
	This figure represents the AWPU factor and Premises Factor (pupil element). Other factors in the CFF are dependent on pupil numbers, floor areas and JSA/IS-entitlement etc. therefore cannot be estimated at this time.
	The estimated staff costs are £50,000. The SEELB has advised that it will fund accommodation costs through its minor works budget, subject to the availability of capital funds.
FOI Implications:	The content of this submission is likely to be fully disclosable.
Legislation Implications:	N/A
Presentational / Contentious Issues:	It is likely that there will be local media and political interest in your decision and about the level of pre-school provision in the area. (<i>This has been cleared with the Communications Team</i> .)
Recommendation:	It is recommended that you approve the proposal to establish a new part time nursery unit at Ballymagee PS and agree the attached press release (Appendix D).

Background

On 13 November 2012, the South Eastern Education and Library Board (SEELB) published Development Proposal (DP) No. 232, which proposes the establishment of a part-time nursery unit at Ballymagee PS with effect from 31 August 2013, or as soon as possible thereafter. The unit will accommodate 26 part-time places. The statutory two-month consultation period ended on 13 January 2013.

2 Ballymagee PS is a controlled co-educational Primary school situated at Ashbury Avenue, between the Gransha and Ballycrochan Roads in the Bangor East District. The school opened in September 1994 in purpose built accommodation.

3 The Early Days Playgroup is already located within the youth wing attached to the Primary school and the SEELB has confirmed that it will continue to operate.

Policy Context

Level of Provision and Pattern of Attendance

4 The current aim of the Department's Pre-School Education Programme (PSEP) to provide one year of funded pre-school education for every child whose parents wish to avail of it is included as a Programme for Government 2011-15 commitment.

5 In addition it is the Department's policy not to displace good quality pre-school provision already in existence with pre-school provision in an alternative setting. DE is also of the view that the pre-school phase is non-sectoral. Therefore, in considering proposals for the establishment of new statutory nursery provision, the overall level of provision in an area is taken into account.

6 The EPPNI (Effective Pre-school Provision in NI) research shows that full-time attendance offers no discernible benefit to children over part-time sessions. However from the outset of the PSEP, for historical reasons funding has been provided for both full-time and part-time provision. A focused consultation on 'Learning to Learn, A Framework for Early Years Education and Learning' is currently ongoing and runs until 31 January 2013. This framework proposes a moratorium on any new or additional full-time provision or conversion from part-time to full-time.

Development Proposal

7 Statistical information relating to the proposal is contained in **Appendix B**. The key issues may be summarised as follows:-

- The proposal is for part-time provision which is in accordance with the proposals in the new framework for Early Years.
- The projected level of provision for 2012/13, as analysed by the Early Years Team, is 91% within a 2 mile radius of Ballymagee PS and 87% within a 5 mile radius.
- There were 12 children, the majority of whom were in Bangor, unplaced in the SEELB area at the end of the process for September 2012 admissions. The SEELB had difficulty sourcing additional voluntary/ private provision in the area. This would breach the PfG commitment.
- Primary school pupil population projection figures for the North Down area show a steady increase until 2018.
- A high-level funding estimate for a 26 place part-time unit, using 2012/13 Common Funding Formula values, is £49k (full year) and £28k (in-year).
- There are additional staff costs of around £50,000 plus accommodation costs estimated at £140,000.
- The SEELB has confirmed that the existing Early Days Playgroup will continue to operate.
- The proposal is supported by the Early Years Team and by the ETI.

Board Comment

8 The SEELB advises that there has been pressure for pre-school places over the past number of years within Bangor town, specifically in the Ballycrochan, Ballyholme, Ballymaconnell and Ballymagee wards.

9 The Board believes that the establishment of a new nursery unit at Ballymagee PS is appropriate due to the continuing problem of insufficient places in the area.

Support and Objections

10 The Department did not receive any correspondence on the proposal during the statutory two-month consultation period. The SEELB received 3 responses to their consultation, all supportive of the new nursery unit. One from the existing Early Days Playgroup comments that they hope to work in partnership with the new nursery.

Consultation

11 The SEELB has confirmed that it has fulfilled its statutory duty in relation to consultation and has provided proof of publication.

Conclusion and Recommendation

12 There has been pressure over the past number of years for pre-school places in the area and rising pupil population projections will exacerbate the situation.

13 The proposal has unanimous support from the SEELB, the Early Years Team and the ETI.

- Table 3 above shows that although funding is only provided for 210 places in playgroups in the area there are in fact in 2012/13 297 pupils attending.
- The nursery schools and units are full to capacity as shown in Table 4. Since 2010/11 no child under 3 has attended any of the nursery schools or units.
- Table 6 shows a steady increase in the primary pupil population in North Down until 2018 so the demand for nursery places will also increase.

SEELB PEAG Comments

The Pre-school Education Advisory Group for the South Eastern Area considered statistical data provided by the Department of Education regarding the pre-school provision in each Ward area and the shortfall of provision against the target population.

The Group found that there has been pressure over the past number of years for pre-school places within Bangor town, specifically in the eastern part of the town comprising of the Ballycrochan, Ballyholme, Ballymaconnell and Balymagee Wards.

ETI Comments

Initial Comments

Initially the ETI recommended that the proposal, to establish a single, part-time nursery unit in Ballymagee Primary School, Bangor, should not be accepted.

This recommendation was made on the basis that the nursery:-

- Could displace the existing voluntary provision at the Early Days Playgroup.
- Such a closure would lead to loss of jobs as the majority of the playgroup staff would be unable to transfer across to nursery unit.
- Further, if DE were to approve the statutory provision, it would require the provision of a new classroom, appropriate resources and the appointment of a qualified pre-school teacher and, therefore, increased costs.

Revised Comments

The initial ETI response was written without the detailed data now available.

Given the under-provision in the area, ETI would therefore **support** the establishment of a part-time unit at Ballymagee Primary School.

Early Years Team (EYT) Analysis and Comments

Level of Pre-School Provision

 The need for additional places in the area is supported by the statistical information available in relation to this proposal.

- There were 12 target age children unplaced in the SEELB area at the end of the process for September 2012 admissions, the majority of whom were in Bangor. The SEELB had difficulty sourcing additional voluntary/private provision in the Bangor area to meet the shortfall in demand.
- Provision is currently insufficient to meet the PfG commitment that a pre-school place should be available for every child whose parents seek one. Even with the

approval of 26 additional places there would still be a shortfall in provision in both the 2 & 5 mile radius.

<u>Analysis</u>

- The Pre-School Education Programme (PSEP) has developed as a genuine partnership between the statutory and voluntary/private sectors. The Department's policy is that each sector is equally valued with both following common curriculum guidelines and being subject to the same inspection standards.
- The Department's policy is not to displace good quality pre-school provision already in existence with pre-school provision in an alternative setting. Therefore the Department would not, unless in exceptional circumstances, support a proposal to establish or increase provision in an area where there is a sufficient level of quality pre-school provision (irrespective of the type of provider).
- There is however a pattern of under-provision in this area over the past few years which, unless addressed, will inhibit the Department's ability to meet the PfG commitment.
- The SEELB has stated in their Development Proposal that the existing voluntary playgroup (Early Days), which is located within Ballymagee PS and currently offers 24 funded pre-school places, will continue to operate.
- The shortfall in provision in this area is such that the creation of a new nursery unit, increasing provision within a 2 mile radius to 95.3%, should not have a detrimental impact on the existing voluntary provider.

Recommendation

 Early Years Team supports the proposal to establish a 26 place p/t nursery unit at Ballymagee PS.

Financial Implications

If the proposal were approved the following financial implications need to be considered:

(a) Accommodation

The South Eastern Education and Library Board will finance the required accommodation for the proposed nursery through its minor works allocation subject to the availability of capital funds. The building cost would be approximately £140k.

(b) Common Funding Scheme – additional allocation

A high-level funding estimate based on the above, using 2012/13 CFF values, is £49k (full year) and £28k (in-year).

Note:


A more robust calculation could only be done on opening of the unit, when the actual pupil numbers and data affecting the other factors in the Common Funding Formula (e.g. TSN) would be known. These additional factors would increase the resource requirement, perhaps substantially.

In the current financial climate, School Finance Team are concerned that approval of this Development Proposal will increase pressure on an already severely stretched Aggregated Schools Budget.

(c) Staffing costs

The estimated staffing costs as provided by the SEELB are £50,000.

O'DOWD APPROVES PART-TIME NURSERY UNIT AT BALLYMAGEE PRIMARY SCHOOL, BANGOR.

Education Minister, John O'Dowd, has approved the establishment of a 26 place part-time nursery unit at Ballymagee Primary School, Bangor.

Commenting on his decision, the Minister said: "The establishment of this new facility will be welcome news. I am satisfied that there is a clearly demonstrated need to create more pre-school places for the benefit of the children in the area."

"It is well-established that high quality pre-school education has a positive impact on children's educational outcomes. To this end, a key Programme for Government target for my Department is to provide a place in their immediate pre-school year for all children whose parents wish it. This increased provision at Ballymagee will help achieve this aim in Bangor."
