# Background

On 29 October 2014, the WELB, at the request of CCMS, published Development Proposal (DP) No. 265, proposing that St Anthony's PS should close from 31 August 2015, or as soon as possible thereafter. The statutory two month objection period ended on 29 December 2015. A copy of the proposal is attached at **Appendix A**.

2. The approved admissions and enrolment numbers of St Anthony's PS are 15 and 106 respectively.

3. CCMS initiated a consultation regarding the future of this school in light of the *Policy* for *Sustainable Schools* and the ongoing Area Planning process. CCMS's Case for Change in bringing forward the DP is set out in **Appendix C** and statistical information relating to the proposal is provided at **Appendix D** below. The main points may be summarised as follows:-

- Enrolments indicate that the school is not viable. There was one pupil in the Primary 1 intake at the school in the 2013/14 school year and the enrolment has reduced to 14 pupils in the 2014/15 school year. This is significantly below the minimum enrolment threshold of 105 for rural Primary schools specified in the *Policy for Sustainable Schools*.
- Enrolments have been decreasing over a number of years (61 pupils in 2004/05 to 14 pupils in 2014/15).
- The quality of education is difficult to maintain due to composite classes involving three and four year groups.
- There are sufficient unfilled places locally to accommodate the St Anthony's PS pupils. There is spare capacity (298 places) at several other local Catholic Maintained schools within a five mile radius.
- The children will move to larger classes where they will have access to greater social interaction and a greater opportunity for healthy intellectual involvement with peers.
- A deficit of -£125,825 is forecast by March 2017 which is deemed to be irrecoverable.

# Alternative provision

4. There are currently 298 spare places in two WELB Catholic Maintained schools locally. Inclusion of a nearby North Eastern Education and Library Board (NEELB) Catholic Maintained school increases the number of spare places to 344. This is set out in detail in Appendix D below.

# **Financial Position**

5. St Anthony's PS had a cumulative deficit of -£7,453, or -4.24% of available delegated resources, at March 2014, the most recent set of finalised data available. The WELB Funding Authority considers the school's financial plans unacceptable and its deficit irrecoverable. The forecast position is a deficit of -£125,825 or -243% of available delegated resources at March 2017. Any closing deficit will have to be written off in full from ELB Centre Funds.

# WELB Primary Schools Area Plan

6. In the most recent WELB Primary School Area Plan (23 June 2014), the following commentary was provided regarding St Anthony's PS:-

A number of issues in the school/local area have been identified.

- More than 2 composite classes in a single classroom.
- 2 teachers in 2013/14.
- School's enrolment for 2013/14, 21 pupils, is below the minimum enrolment threshold detailed in the Sustainable Schools Policy.

# Education and Training Inspectorate (ETI)

7. The ETI supports the proposal to close St Anthony's PS, making the following points:-

- The school has seen its enrolment reduced by approximately three-quarters over the past 10 years or so.
- The enrolment is not sustainable, with no children in the foundation stage and only three children in Key Stage 1
- The school has difficultly providing a suitable broad and balanced curriculum which reflects the statutory requirements to meet the needs of all the children.
- The area in which the school is situated has restrictions on new residential developments.

Full ETI comment is set out at **Appendix E** below.

# Consultation

8. WELB has confirmed that it has fulfilled its statutory duty in relation to consultation and has consulted with all schools likely, in its opinion, to be affected by the DP.

9. Proof of CCMS consultation has been supplied.

# Letters of Support/Objection

10. The Department has not received any letters of support or objection to this proposal.

11. The WELB received a letter from the Chair of the Board of Governors (BoG) of St Anthony's. Whilst the BOG raised some staffing and parent/pupil concerns relating to the school closure (staff redeployment, pupils enrolling in new schools) they stated that they were committed to working with CCMS, WELB and DE to ensure everything would run smoothly for all connected with the school.

# **Conclusion and Recommendation**

12. Enrolments in St Anthony's PS have been in decline for a number of years with no expected prospect of recovery. There are 344 spare places in three local Catholic Maintained schools.

13. The quality of education is difficult to maintain due to composite classes involving three or four year groups.

14. The proposal arises from the work undertaken by the CCMS and is reflected in the WELB Primary Area Plan.

15. WELB projects that the school will have a deficit of -£7,453 in March 2014 and is not financially viable. The forecast position is a deficit of -£125,000 in March 2017.

16. ETI supports the proposal to close – the enrolment is not sustainable, the school has difficulty providing a suitable broad and balanced curriculum and there are restrictions on new residential developments locally.

17. The BoG of the school is committed to assisting CCMS, WELB and DE to ensure the closure of the school runs as smoothly as possible.

18. In the circumstances, closure appears to be in the best educational interests of the children concerned and it is therefore recommended that you:-

• approve the proposal to close St Anthony's PS;

- agree the wording of the DP decision letter (Appendix F); and
- agree that this submission (with any appropriate redactions) can be published on the DE website.



## **CCMS Case for change**

#### 1. BACKGROUND

St Anthony's PS is located close to the village of Magilligan and opened in 1956. There are two primary schools in the parish; of the two parish schools St Anthony's PS is closer to Limavady (4 miles). The children who attend the school are from the parishes of Magilligan and Limavady. Magilligan, where St Aidan's PS is located is a remote rural area which is 9 miles from Limavady and on no direct transport route. Both schools are in the Limavady District Council Area.

The parish of Magilligan is located next to the Parishes of Limavady and Coleraine in the Diocese of Derry. The parish has a population of 1200 people. There are two Catholic Maintained primary schools serving the parish each under the management of a single Board of Governors. Other schools in the immediate area include one controlled primary school.

Applications have recently been submitted and are under consideration for the following:

- Replacement of temporary accommodation
- Provision of a special needs room and resource area

The accommodation does not meet the requirements of the DE Building Handbook.

# 2. RATIONALE FOR PROPOSAL

The rationale for this proposal to cease educational provision in St Anthony's PS by 31<sup>st</sup> August 2015 or as soon as possible thereafter is largely due to population decline in the area and consequently a steady decline in enrolment.

Other options considered:

- School remains open continued pressure on staff to deliver broad and balanced curriculum to mixed aged classes. Significant deficit in budget – leading to further reduction in staff
- Amalgamation with St Aidan's PS, Magilligan not progressed as the two schools combined would still fall well below the recommended minimum enrolment number of 105. Also parents did not wish to send their children to Magilligan which is in a more isolated area (up to 8 miles for some)

• Shared Education with Bellerena Controlled PS – not progressed as neither of the two schools are sustainable under the Policy for Sustainable Schools

## 3. AREA PLANNING IMPACT

#### 3.1 Schools for the Future: A policy for Sustainability [SSP]: 2009.

Under the Sustainable Schools Policy (2009), St Anthony's PS does not meet two of the criteria and will struggle to meet a third:

- Stable Enrolment Trends
- Sound financial position
- Quality Education Experience
- Strong leadership and management
- Accessibility
- Strong links with the community

The **enrolment** now sits at 18, which is well below the DE recommended minimum enrolment of 105 for rural primary schools.

LMS **funding** is based on pupil numbers and with enrolment in such decline the challenge has become acute, with significant deficits accruing.

The **quality of educational experience** is difficult to maintain due to composite classes involving three and four year groups when department policy proposes no more than two year groups in a class.

The potential closure of St Anthony's PS will not have any significant impact on other schools. Parents have indicated that they will move their children to other schools in the area. They have not yet indicated which schools.

#### 3.2 Viability Audits submitted to the Minister in February 2012

Prepared jointly by WELB and CCMS, these audits considered the first three criteria above, and formed the basis of proposals for Area Planning as presented to individual schools in 2012. The purpose of the audits was to identify specific stresses at individual schools, and the extent to which they impact on the school's sustainability.

This viability audit was carried out in 2012. The situation has since changed in St Anthony's PS with the enrolment declining further from 26 to 15 pupils. This has had a significant detrimental impact on the budget (which is now also in significant decline) and is also making it more difficult for the staff to provide a quality educational experience for the remaining children.

# 3.3 Putting Pupils First: Shaping Our Future – WELB Strategic Area Plan.

Action for all primary schools was set out in this document. Consideration was given to the Viability Audits and the Sustainable Schools Policy. The following 'action' was identified for the two parish schools:

## <u>St Aidan's PS:</u>

Local area/parish solution to be explored. A number of issues in the school/local area have been identified:

- More than 2 composite classes in a single classroom.
- 3 teachers in 2012-2013
- School's enrolment for 2012/13, **38** pupils, is below the minimum enrolment threshold detailed in the Sustainable Schools Policy.

## School enrolment for 2014/15 = 46

#### <u>St Anthony's PS:</u>

Local area/parish solution to be explored. A number of issues in the school/local area have been identified:

- More than 2 composite classes in a single classroom
- 2 teachers in 2012-2013
- School's enrolment for 2012/13, **25** pupils, is below the minimum enrolment threshold detailed in the Sustainable Schools Policy.

#### School enrolment for 2014/15 = 18

# 4. EDUCATIONAL IMPACT

The educational benefits of this proposal will be that children will move to larger classes where they will have access to greater social interaction. There will be greater opportunity for healthy intellectual competition among peers.

#### 6. IMPLEMENTATION PLAN

**6.1** The proposal to close St Anthony's PS on 31<sup>st</sup> August 2015, or as soon as possible thereafter, is based on three critical factors as set out above:

- The low, and decreasing enrolment
- A significant deficit budget within three years
- Difficulty in meeting key educational provision indicators as set out in the Schools Sustainability Policy

#### 7. RESOURCE IMPLICATIONS

#### **Resource Implications**

The closure of St Anthony's PS will have the following impact:

#### Finance:

- Any budget surplus in August 2015 will be retained by WELB
- Reliance on Small School Support and Principal Release funding will cease
- Excluding AWPUs [allocated elsewhere] all other costs [premises etc] at St Anthony's PS will cease

# Staffing:

- Possible redundancy costs for teaching and/or non-teaching staff
- Possible costs re salary protection scheme if the principal is redeployed to a lesser position

# Transport:

• Transport costs for pupils: these will be minimal as there are only 18 children currently attending St Anthony's PS

## Analysis of Proposal

## **Quality Educational Experience**

The most recent follow-up inspection was conducted in January 2009. This found the quality of education provided by the school was now good and that the school had important strengths in most of its educational and pastoral provision. The followup inspection had identified that the school had demonstrated the capacity to address some other minor aspects of the areas for improvement.

#### **Enrolment Trends**

The *Policy for Sustainable Schools* states that a rural (outside Belfast and Derry City Council areas) Primary school should have a minimum enrolment of 105 pupils. St Anthony's PS has an approved admissions number of 11 and an approved enrolment number of 75. The enrolment in St Anthony's PS has been declining steadily over the last few years (see Tables 1 & 2 below). Enrolments indicate that the school is not viable.

Table 3 (above) provides detail of available capacity within other local maintained schools. The *Policy for Sustainable Schools* provides a "rule of thumb" home to school travel time of less than 30 minutes (i.e. 1 hour per day in total) for Primary pupils. Travel times in the event of the closure of St Anthony's PS are unlikely to exceed this threshold.

# **Financial Viability**

WELB projects that the school will have a deficit of -£7,453 in March 2014 and is not financially viable. The forecast position at March 2017 is a deficit of -£125,825.

# Links with the Community

The WELB received a letter from the Chair of the BoG of St Anthony's highlighting some concerns pertaining to the potential closure (staffing issues, parent queries and general uncertainty) but also noting that the BoG recognised the impact that the small pupil numbers had on the educational and social needs of the pupils. They pledged to work closely with CCMS, WELB and DE to ensure that the closure of the school ran as smoothly as possible.

# Appendix E

#### **Department of Education and ETI comment**

#### **School Finance Team**

St Anthony's PS had a cumulative deficit of -£7,453, or -4.24% of available delegated resources, at March 2014, the most recent set of finalised data available. The WELB Funding Authority considers the school's financial plans unacceptable and its deficit irrecoverable. The forecast position at March 2017 is a deficit of -  $\pounds$ 125,825 or -243% of available delegated resources.

The 2014/15 allocation to St Anthony's PS for the Small Schools Support Factor is £42,008.

#### Per Capita Allocations

The school's 2014/15 per capita allocation is £7,205; this is substantially higher than the average per capita for a WELB Primary School of £3,188.

#### ETI comment

The Western Education and Library Board published Development Proposal No 265 on 22 September 2014:

St Anthony's Primary School, Bellarena will close with effect from 31<sup>st</sup> August 2015, or as soon as possible thereafter.

#### ETI supports this development proposal.

 St. Anthony's Primary School has seen its enrolment reduced by approximately three-quarters over the past 10 years or so. The two teachers have responded very professionally and the school is very well presented; the learning environment is stimulating and very effective use is made of the outdoor areas to support and enhance the children's learning experiences.

However, the enrolment is not sustainable and with no children in the foundation stage and only three children in key stage 1, the opportunities for them to develop their cognitive, personal and social skills, despite the best efforts of the teachers, are limited.

In addition, it is difficult to provide a suitable broad and balanced curriculum which reflects the statutory requirements and provides an appropriately wide range of non-formal and extra-curricular activities to meet the needs of all the

children, with a significantly increasing budget deficit. It is appropriate that the Board of Governors (BoG) has recognised these difficulties in its letter of 9 October 2014.

• The school is situated in an area of outstanding natural beauty with restrictions on new residential developments.

There is another maintained school approximately five miles along the road (St.Aidan's Primary School, Magilligan) whose enrolment has remained above 40 children in four of the last five years (and currently stands at 46). There is a controlled school, Bellarena Primary School, approximately two miles along the road with a steady enrolment of just below 40. These provide the parents with a choice of small, local, rural schools should they not wish to send their children to Limavady, approximately four miles away.
