REVISED ARRANGEMENTS FOR THE PAYMENT OF SALARY TO CERTAIN PART-TIME TEACHERS PAID ON A PRO-RATA BASIS

- 1. At present all teachers who are employed in a part-time capacity in grant-aided schools in Northern Ireland are paid salary in the middle of the month following the month in which they are employed. Agreement has now been reached at the Teachers' Salaries and Conditions of Service Committee (Schools) to pay the salary of those part-time teachers who have been appointed in a permanent capacity or who have been appointed for a continuous period of 12 months or more to be paid along with permanent full-time teachers on the last working day of the month.
- 2. This will take effect in January 1995. As a transitional arrangement this category of part-time teacher will be paid on 18 January 1995 for work carried out in December 1994 and again on 31 January 1995 for work carried out in the month of January 1995. Thereafter they will be paid on the last working day of each month.
- 3. These 'pro-rata' teachers will be included in the monthly return Certificate of Service of Permanent Teaching Staff with effect from the month of February. Form TR141A Certificate of Service of temporary/part-time teaching staff should no longer be used to record their contractual service in the school with effect from February 1995.
- 4. Where a teacher is required to undertake additional directed time beyond that provided in his contract he will be paid on a pro rata basis for each extra hour. A new form TR 269 has been introduced for use by the school to notify the Department of any additional hours worked by the 'pro-rata' teacher over and above the contractual hours.
- 5. A part-time teacher however must not be employed for more than 1,265 hours in any school year (32.4 hours per week) and cannot be paid more by way of salary in respect of accumulated service then he would have received had he been employed in a full-time permanent capacity throughout the year.
