The implementation of the strategy applies equally to both rural and urban areas.

The Strategy has been guided and shaped by many informed contributions, including several evaluations of funded Shared Education programmes, seeking views from practitioners, children and young people, and academic research. It has been developed by the DE, working closely with other educational bodies, and in consultation with a bespoke Stakeholder Reference Group. The Strategy aims to increase the levels of participation in Shared Education partnerships, regardless of their rurality, to provide all children and young people with the opportunity to be involved.

SECTION 4 - Considering the Social and Economic Needs of Persons in Rural Areas

4A. Please provide details of the issues considered in relation to the social and economic needs of people in rural areas.

The implementation of this strategy applies equally to both rural and urban; the introduction of this strategy does not impact differently on rural and urban needs. The Strategy recognizes the diversity across the education system in Northern Ireland and sets out how it will support partnerships to bring children and young people from different communities together. For example the Strategy proposes to provide funding to support the transport costs of moving pupils between schools recognizing this as an additional inescapable cost of Shared Education delivery, which can apply in any circumstance including rural communities, as well as those schools located in urban areas.

The needs of rural communities in relation to Shared Education are the same as those in urban areas. There are additional costs to sharing which the Strategy identifies and proposes providing funding to support. There is a requirement to upskill the education workforce to make it confident and competent in delivering shared lessons. There is a need to provide the resources, infrastructure and support to enable Shared Education partnerships to deliver high quality shared learning experiences to their pupils. All of these needs equally apply to schools and other educational settings in rural and urban areas.
