A Childcare Reference Group has been established with representatives of childcare support organisations, which includes: the Northern Ireland Childminding Association (NICMA), Employers for Childcare (EfC), Play Board and Early Years Organisation (EYO)- an organisation for young children, representatives from Community and Voluntary sector, Altram, Private Day Care Committee, NI Day Care Owners, Employers forum and parents representative through Parentline. These organisations represent the views of providers in urban and rural areas/settings.

NICMA, EfC, EYO and PlayBoard have carried out numerous surveys, including one in May 2020, to identify and assess the needs of providers in urban and rural areas.
